

Terms & Conditions for participants of SBI Card #ForeverGrateful Contest:

By participating in this #ForeverGrateful contest, participants accept and agree to be bound by the following Terms and Conditions. This contest and the Terms and Conditions are subject to the laws of India, and are not offered outside of India.

1. SBI Cards and Payments Services Limited (“SBICPSL”) (hereinafter referred to as “SBI Card”) is holding a contest, # ForeverGrateful” (hereinafter referred to as “the Contest”) which is valid throughout India except in the states, where prohibited by any applicable law, from 7th to 30th July 2021 (herein after called “Contest Period”);
