

Terms and Conditions

General Disclaimers

1. Offer Eligibility: This Offer ('Offer') from SBI Cards and Payment Services Limited (hereinafter referred to as 'SBICPSL') is open to newly sourced customers during 1st April'26 – 30 April'26. Corporate and other non IndiGo SBI Card(/s) Cobrand card sourced variants are not eligible.

2. Offer Applicability: The Offer is applicable on customers who comply or fulfill Minimum Spends Criterion as determined by SBICPSL.

3. Offer Details: Under this offer, eligible:

- IndiGo SBI cardholders will receive assured 2500 IndiGo BluChips Voucher on achieving the required Minimum Spends Criteria within 30 days from account opening.
- IndiGo SBI Card ELITE cardholders will receive assured 5000 IndiGo BluChips Voucher on achieving the required minimum spends criteria within 30 days from account opening.

4. Eligible Transactions: No exclusions for achieving the spends threshold.

5. Minimum Spends Criteria:
