

### **Flexipay EMI Offer -Amazon Pay Gift Card Terms & Condition**

#### **Offer Validity: 16<sup>th</sup> Apr'26 to 15<sup>th</sup> May'26 (both dates included)**

1. This offer is on Flexipay EMI facility and is open only to those SBI Credit Cardholders ("Cardholders") who have received the offer from SBI Cards and Payment Services Ltd. ("SBICPSL" or "SBI Card") through an appropriate communication medium decided by SBICPSL for the account selected for this offer.
2. The Offer is not available to a delinquent, or any other ineligible Cardholders determined as per the internal policy of SBICPSL. Accordingly, the approval of Flexipay EMI facility is at the sole and absolute discretion of SBICPSL.
3. This offer is valid only for Flexipay EMI Service Request raised between 16<sup>th</sup> Apr'26 and 15<sup>th</sup> May'26, both days inclusive ("Offer Term"). Any Flexipay EMI service request raised after 15<sup>th</sup> May'26 will not be eligible for Amazon Pay Gift Card.
4. 12. In case the Cardholder fails to inform issue related to the offer within 30 days from offer fulfillment date, SBICPSL shall have the right to not entertain such grievances from the Cardholder.
13. SBICPSL will not be responsible if the SMS is not delivered, mobile number is not updated, or the incomplete mobile number is updated in the system, etc. SMS will be sent to mobile number as updated in SBICPSL's system.
14. SBICPSL will not be responsible for non-delivery of Amazon Pay Gift Cards code to redeem gift in case the mobile number is on NCPR (National Customer Preference Register) / DND as per applicable regulation.
15. In case of any dispute, the decision of SBICPSL shall be final and binding.

Except as provided hereunder or as per applicable law, amount in your Gift Cards will not be refunded to you under any circumstances. No refund will be provided in cash, at any point of time. Unused Gift Card balances may not be transferred to another user's account. No interest will be payable by Pine Labs on any Gift Card or Gift Card balance. Pine Labs make no representation or warranty that Amazon.in will always be accessible without interruption.
